

# SOUTHWATER NEIGHBOURHOOD WARDENS' REPORT June 2019

#### Introduction

Following our mandatory Core Skills, CSAS and First Aid training we started in the parish on Wednesday 22nd May. We met with the Parish Council Chair, Graham Watkins, Parish Councillors Pauline Flores-Moore and Hayley Timson and District Councillor Claire Vickers. Hayley then showed us around our parish, introduced us to some of the retail business owners and pointed out areas of interest.

Having viewed and analysed the crime statistics for our area listed at <a href="https://www.police.uk/sussex">www.police.uk/sussex</a> it is clear that overall (including Broadbridge Heath) there were 57-67 crimes reported to police each month over the last 6 months.

We have been incorporating many of the community issues raised in the Parish including the reporting and collecting of litter, overflowing or damaged bins, cycling prohibitions, playground inspections and graffiti for removal.

We have re-visited local shops and businesses ensuring that they have sufficient leaflets and to secure any initial thoughts or comments from local residents about our role or areas of concern.

#### **Patrols**

- Initial foot patrol to local businesses and shops
- School patrols at beginning and end of school day
- Playground and open spaces inspections
- Mobile patrols (including sites of recent fly-tipping) to parish boundary (Christs Hospital/Two Mile Ash)
- Regular hi-visibility foot patrols to old Skate Park to monitor condition and use and to new Skate Park to deter unauthorised access

#### Criminal damage

#### Reported to HDC:

- Grafitti on electric sub-station Blakes Farm Road
- Grafitti on old A24 bridge over Downslink path
- Graffiti on litter bin at old skate park in Stakers Lane
- Graffiti under bridge Stakers Lane under A24 by-pass

Outcome – all above has been removed after reporting

## Anti-social behaviour

- Responded to resident complaint re: youths on bench in twitten near York Close
- Cycling prohibition advice/enforcement (Lintot Square)
- Responded to intelligence from Parish employee re: ASB young people using the new skate park in evenings

 Passed intelligence re: teenagers/alcohol/cannabis and proposed party to Damian Cecil

# **Parking**

- School parking patrols at Southwater Academy
- Responded to resident re: high sided vehicles parking inconsiderately in Cedar Drive
- Responded to resident re: vehicles parking on double yellow lines in Woodlands Way – parking alerts issued and Parking Services attended

Reported one empty deal bag on Pevensey Road playground area

Reporting of overflowing litter bins

# Fly-tipping

 Regular mobile patrols to edges of boundary (Two Mile Ash/Christs Hospital) to check for fly-tipping.

# Dog fouling / issues with dogs

• Reporting of overflowing/broken dog bins

Outcome – bins have been mended/emptied after reporting

 Have received list of vulnerable people and currently liaising with Community Link to finalise process before starting vulnerable people visits.
